At the June 2, 2022 meeting, the Assembly postponed a motion "to protest liquor license application #5658" until the first Assembly meeting in July.

There is currently an active motion to protest liquor license application #5658.

Since the June 2, 2022 meeting, none of the following concerns have been remedied:

• Pursuant to SMC 5.12.030 Municipal business license required – There is not a current Municipal Business license for Garden City Enterprises, LLC, or Jewell Gardens.

SMC 5.12.030 Municipal business license required.

Notwithstanding possession of a valid marijuana or alcoholic beverage license from the state, every person engaged in a "business" (as defined in Section 5.04.010) involving marijuana or alcoholic beverages shall be subject to the provisions of Chapter 5.04 of this title concerning business licenses.

 Pursuant to SMC 5.12.040 Recommendation by assembly – There are several debts owed to the Municipality, including utilities, bills from the Harbor, and sales tax remittance for rental properties.

SMC 5.12.040 Recommendation by assembly.

Any person seeking the recommendation of the municipality, prior to issuance or renewal of a marijuana or alcoholic beverage license by the state, shall present to the assembly a copy of his application to the state for a license or renewal fully completed and executed, together with a current statement prepared by the borough clerk that any and all taxes, fees, assessments, utility bills and remittance of sales tax due to the municipality by the applicant have been paid in full.

Staff recommends the Assembly protest this license renewal.

If the vote to protest passes, the following motion *should* be made:

I move we protest liquor license renewal application #5658 for the following reasons:

- 1. The application is out of compliance with SMC 5.12.030 Municipal business license required.
- 2. The applicant maintains several debts to the Municipality, including utilities, bills from the Harbor, and sales tax remittance for rental properties, which causes the application to be out of compliance with SMC 5.12.040 Recommendation by assembly.

Should the Assembly protest, a public hearing must be scheduled to provide an avenue for the applicant to defend the application. **This is required by State Statute**. Due to the postponement in considering the protest, there is little time to hold a hearing. The Assembly must now vote to schedule a hearing for a date occurring on or before July 14, 2022. The deadline to file a protest is July 15, 2022 however, staff require that day to complete the process.
