A RESOLUTION OF THE MUNICIPALITY OF SKAGWAY, ALASKA ADDING MUNICIPAL FINES TO THE FINE SCHEDULE AND CONSOLIDATING EXISTING FINES.

WHEREAS, the Municipality has established fines via many separate resolutions for violations of code requirements; however, some violations of code do not currently have fines associated with them, which hampers the Police Department’s ability to enforce those code requirements; and

WHEREAS, establishing currently missing fines for code violations will provide a mechanism for the Police Department to efficiently enforce municipal code; and

WHEREAS, the Municipality wishes to supplement the existing fine schedule in order to fully cover all regulations in municipal code that may be violated; and

WHEREAS, the Municipality wishes to consolidate and re-establish existing fines within this resolution, for ease of use and efficiency;

NOW, THEREFORE BE IT RESOLVED, by the Borough Assembly of the Municipality of Skagway that the following municipal fines are added to the existing fine schedule:
