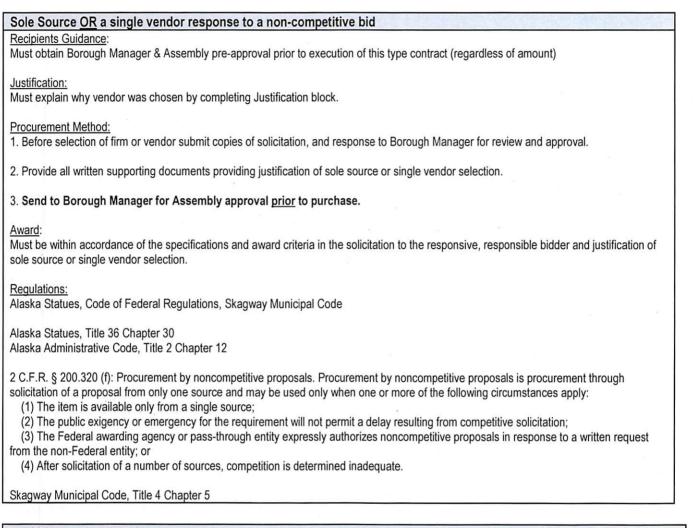

 - Costs to transition to another product that outweigh any potential savings.
