Please see the email and grant information in the meeting packet. There are many details that would be worked out in the planning phase of this project, if DOT&PF is awarded the grant funding, including development of a future memorandum of agreement between DOT&PF and MOS. If awarded, the project funding match of 20% would be supplied by the State of Alaska.

The Skagway 2030 Comprehensive Plan indicates that, "to incentivize greater use of electric personal and commercial vehicles, the Municipality could on its own or in partnership with businesses, install electric vehicle charging stations, ramping up 'charging for a charge' fees over time to cover infrastructure costs" (p. 71). In order to meet the plan's Transportation Objective of reducing Skagway's greenhouse gas emissions, one of the proposed actions is to "install electric vehicle charging stations" (p. 78). If Skagway participates in this DOT&PF program, it will be able to utilize federal and state funding to jump-start its adopted action plan.

For now, MOS can generally support DOT&PF's application by providing a letter of support (attached). Staff requests that the Assembly consider a motion to the draft letter of support.
