- He would like to see some action on the Garden City RV Park to address housing concerns.
- The 2024 Alaska Marine Highway summer ferry schedule has been released and it has a substantial increase in service to Skagway. AMHS DOT is accepting comments until December 18th and if there is no objection from the Assembly, he will send a letter of support from the mayor's office.

Manager Ryan indicated that:

- He will provide a weekly update on the port project.
- Only one bid of \$25,000 was received for the Truck in Ground equipment. The minimum bid was \$50,000 so he will need direction regarding going out to bid again or awarding that bid.
- He attended the Alaska Municipal League conference where the use of artificial intelligence was discussed. He intends to provide the assembly and staff with some guidance on using this tool.
- He intends to invite other communities to join the AP&T rate filing case.
