**A RESOLUTION OF THE MUNICIPALITY OF SKAGWAY, ALASKA UPDATING FEES FOR THE SKAGWAY RECREATION CENTER AND REPEALING RESOLUTION NO 17-20R.**

**WHEREAS**, the Recreation Board met on March 29, 2024, and voted to recommend an updated fee structure for the Recreation Center to the Assembly for consideration;

**WHEREAS, the Recreation Board recognizes that the current fee structure has not been changed since 2017 and yet operating costs have increased and continue to do so annually; and**

**WHEREAS, the family membership fee option poses a safety issue because it does not identify the specific member or members who have checked in, and it restricts the Recreation Center's ability to gather data regarding operating hours and programs.**

**NOW, THEREFORE BE IT RESOLVED**, by the Borough Assembly of the Municipality of Skagway that the recommended fees in Attachment A are approved and established as the Skagway Recreation Center fees; and

**BE IT FURTHER RESOLVED**, that this resolution replaces the previous fee structure, and therefore Resolution No. 17-20R is hereby repealed; and

**BE IT FURTHER RESOLVED**, that the Recreation Board will revisit the Recreation Center fees periodically and make recommendations to the Assembly.
