Manager's Update – May 16, 2024

AIDEA Visit: Representatives from AIDEA visited Skagway to discuss the future of the Ore terminal. We had a good discussion and encouraged them to relay to the governor that we appreciate the \$1 million budget item in the State of Alaska Budget to begin demolition of the terminal. Additionally, we discussed the potential of AIDEA providing funding for the cleanup and removal of the relic ore dust associated with AIDEA's export of copper ore from the Minto Mine.

Main Street Condition Assessment: Surveyors are in Skagway for the Main Street assessment project, and they began their work developing a topographic survey on Wednesday, May 15.

Credit Union Representative Visit: I met with representatives of Tongass Credit Union on Monday, May 13. They discussed the products and services that the credit union can offer, the economy of Skagway, as well as what a potential location in Skagway would look like. The potential location would likely be a small branch in the lobby of another facility. They did mention that the rent for the facility would have to be free for the first year at least. The representatives indicated they would stay in touch, and they asked that the Municipality let them know of any potential locations.

Skagway River Levee Rehabilitation Project: Funding has been approved for the US Army Corps of Engineers to conduct the Skagway River Levee Rehabilitation Project. Once funding is received, the engineering and design phase will start. Construction is estimated to be in Fall of 2025 – Spring of 2026.

Abandoned or Impounded Vehicles, Trailers, & Boats: Attached to this update are documents related to the procedure for impounding vehicles, trailers, and boats.

Port Director's Report: Please see the Port Director's report attached to this update.

Ore Cruise Dock: I am very happy to report the cruise dock at the Ore peninsula has been completed and we have successfully hosted two cruise ships. While the dock has been installed, this is only the beginning of our efforts and we intend to continue upgrades as time and financing allows.

As of May 12, two ships (4100 pax) have cancelled their calls in May.

Ore Peninsula Redevelopment Update: The cruise float installation and ramp setup were completed on May 7. The contractor promptly began installing the final handrails, finishing the punch list, and demobilizing. The tugboat Marie H arrived in Skagway on Monday, May 13, and quickly departed with the crane and materials barge. We hosted our first cruise ship, the Koningsdam, on Tuesday, May 14. Pacific Pile and Marine are finalizing cleanup and closeout activities, with departure scheduled for the end of the week.

<u>2024 Transportation Orientation:</u> We hosted our annual transportation meeting on May 2, featuring speakers from the Port, Skagway Visitor Department, Police, Fire Department, US Customs and Border Patrol, Canadian Border Services Agency, Cruise Line Agencies of Alaska, S.M.A.R.T., and WP&YR. The presentations covered topics including safety, security, border requirements, shuttle services, loading and parking zones, permitting, and general dock operations. The event was well attended, indicating a potential need for a larger venue in the future. Feedback was positive, with attendees appreciating the valuable information shared. The meeting was attended by 59 individuals representing 31 businesses.

<u>Inaugural Visits Silver Nova and Celebrity Edge:</u> The Port of Skagway welcomed the Silver Nova on its inaugural call on May 13, 2024. We participated in a traditional plaque exchange and toured the ship. The Silver Nova is scheduled to make 19 calls, bringing an estimated 14,000 guests to Skagway in 2024. On Tuesday, May 21, 2024, we will similarly welcome the Celebrity Edge to recognize its inaugural season in Alaska.

FY24 Port Infrastructure Development Program (PIDP) Grant: On Friday, May 10, 2024, we submitted our PIDP Grant application. A special thank you to our Port Administrative Manager, Rebecca Kameika, for her exceptional effort. Rebecca led this project, collaborating with our team and partners such as KPFF and FCMC to develop a robust application. The FY23 PIDP award recipients were announced in November 2023, and we expect a similar timeline for 2024.

<u>Rockslide Update</u>: At the April 18th meeting, the Assembly approved a scope of work submitted by Shannon & Wilson to conduct a hazard evaluation of the slope risks above the WP&YR dock. This evaluation is expected to commence in mid-July.

Abandoned or impounded vehicles/trailers/boats

- 1. Marking of Cars: Identify and mark cars that have been parked and unmoved for more than thirty days.
- Notification to Owner: Place red tow stickers on the window of marked vehicles and send a letter to
 the last registered owner, notifying them that the vehicle will be impounded if not moved within 10
 days.
- 3. **Public Works Notification:** Notify the Public Works department to pick up the vehicles for impoundment.
- 4. **Vehicle Impoundment:** Public Works will pick up the vehicles and move them to an impound location.
- 5. **Impoundment Notice:** Send a notice letter of impoundment to the last registered owner, stating that the vehicle will be sold at auction or destroyed if not claimed within 30 days.
- 6. **Fines and Fees**: The last registered owner will receive fines, tow fees, and storage fees associated with the removal and impoundment of the vehicle.
- 7. **Claiming Impounded Vehicle:** To claim the impounded vehicle, the last registered owner must fill out a form signed off by the Police Department and pay associated fees.
- 8. **Destruction Costs**: If the vehicle is not claimed within 30 days, the last registered owner will be responsible for the destruction costs if the vehicle is not auctioned.
- 9. **Vehicle Transfer**: Vehicles will be transferred to the Borough by abandoned vehicle statute and either destroyed or auctioned.
- 10. **Collections**: If fines and fees are not paid, the last registered owner will be turned over to collections for the balance, even if the Borough transfers the title by abandoned vehicle statute.

Average cost per vehicle will include:

Hauling of vehicle \$300.00

Impound of vehicle \$100.00

Storage of Vehicle \$300.00/ per month

Destruction of vehicle \$220.57 if charged

\$700.00 to \$1000.00 depending on destruction costs or if any special equipment costs needed for removal.

(Destruction can be reduced as this is for when individuals come in to have a vehicle removed from their property with a title) (these vehicles are already removed and stored at impound)

WHEREAS, violations of Skagway Municipal Code Title 9 Public Peace, Safety and Welfare shall be subject to civil fines established by resolution;

NOW, THEREFORE BE IT RESOLVED, by the Borough Assembly of the Municipality of Skagway that the following civil fines are established for each violation of Title 9:
