Program Outline

On September 2, 2021 the Borough of Skagway Assembly approved \$1.2 million of the granted NCL funds to offer a Small Business Emergency Grant Program to the impacted businesses of Skagway.

The program is open to all Skagway-based businesses that are not excluded by the various terms listed in the 'program eligibility exclusions' section.

Through this program, The Municipality of Skagway will offer eligible businesses the opportunity to apply for a non-competitive grant.

This program aims to support all Skagway-based businesses that have been drastically impacted by the ongoing coronavirus pandemic while prioritizing those that experienced the greatest loss and/or received minimal other coronavirus grant relief funds from Federal, State or Local sources.

The method for allocating the \$1.2 million across businesses will be based on each businesses annual lost revenues from 2019 to 2020 as reported on tax returns of the business applicants but also including any grants or forgiven portions of loans a business received in 2020 and/ or 2021, as well as based on the total 2020 expenses of the business as reported on tax returns.

To ensure all approved applicants receive an economically meaningful amount, minimum grant award to each eligible applicant will be no less than \$1,000 and maximum grant award to each eligible applicant will be no more than \$40,000.

New eligible business' who were licensed and established before March 11, 2020, and who's first year of operations was 2020, their loss will be determined as the overall average loss experienced by all applicants.

Existing eligible businesses who were bought / sold in 2019 but before March 11, 2020, and who's first year of operations under that newly acquired owners would have been after July 1, 2019 may elect to either a) use the 2018 or 2019 Gross Annual Revenue from the previous business's owner/s or b) utilize the overall average loss experienced by all applicants.

Small Business Relief Grant FAQ Sheet

Program Eligibility Exclusions

- C Corporation traded on a U.S. stock exchange or a corporate-equivalent entity traded on a foreign stock exchange, and owned in whole or majority-owned by such a publicly traded corporation.
- National or international chains that own and operate a premise in the Borough of Skagway (individually owned-and-operated local franchises are eligible).
- Business with a Borough lien or is in violation of a payment agreement with the Borough. A tax delinquency would not disqualify a business from the grant program unless the borough has initiated a lien on that debt. Businesses that have entered into a payment plan with the Borough and are adhering to that plan would be eligible for the grant, so long as the lien has been lifted.
- 4. Businesses currently in bankruptcy proceedings.
- 5. Business not licensed and established in Alaska when the public health disaster emergency declaration was issued by Governor Dunleavy on March 11, 2020.
- Businesses that received industry specific grants from Federal, State, or Local government sources greater than \$5,000 (including but not limited to Restaurant Revitalization, Shuttered Venue, Coronavirus Economic Relief for Transportation Services, USDA Coronavirus Food Assistance Program for Agriculture, CARES Act Relief for Fishery, etc.
- 7. Businesses that loss less than 20% of Gross Annual Revenue in 2020 compared to 2019

Additional Program Requirements

- A business must have been in existence as of March 11, 2020 to qualify.
- Businesses must have held a 2020 State and Local business license.
- Businesses must have experience a 20% or greater loss in Gross Annual Income from 2019 to 2020*
- *2020 Gross Annual Income includes grant funds and forgiven portions of loans offered by Federal, State of Local government bodies in response to the coronavirus pandemic including the MOS's SBEG and SNOW grants, forgiven portion of a business' 2020 1st round PPP loan, any EIDL advancement funds, AK Care funding, etc.
- Businesses must have an up-to-date 2021 State and Municipal business license.
- The physical location of the business must be located in Skagway per the State of Alaska business license list as of August 20, 2021.
- The business owner(s) do not have to be a resident of the Borough of Skagway.
- Businesses sharing physical quarters may each apply and qualify for their own grant but each business must have its own 2021 MOS business license number.
- Eligible entities also include commercial fishermen, non-profits and not-for profits organizations.
- There must be one application per business applying with its own unique 2021 MOS business license number.
- Applicants will be required to check a box that states they intend to remain in business into 2022.
- Applicants are required to self-certify that they have been affected by the COVID-19 public health emergency and resulting economic impacts. The intent of the program is to assist communities and businesses that suffered economic harm from the public health emergency. Impacts could include, though are not limited to, loss of sales due to mandatory shutdown, inventory loss, additional operating expenses of reopening and protecting staff and customers (including funds already spent for those purposes) or debt incurred due to COVID-19.
- The applicant must certify that the information provided is true and accurate and that they agree to assist in the verification of information provided in the application and to provide additional information to SDC, if requested.

It is the intent of SDC, to the extent allowed by law, that the review work, business sensitive information, and the applications themselves, will remain confidential. The names of businesses that receive grants and the amount each receives will be considered a public record.

Application Process

- The application period will be open for two (2) week following the allocation of funds to the program, approval of the program and the completed application.
- Businesses must submit all necessary documents for each business applying. Necessary documents include: completed application; the businesses 2019 and 2020 Federal tax return: schedule C (form 1040) or relatable form depending on business type; current State of Alaska Business License and Municipality of Skagway Business License.
- Once the application period has closed, The skagway Development Corporation (SDC) will review each application submitted by the deadline to validate company identity and eligibility, and to assess the accuracy and completeness of information submitted for application approval. All applications will be subject to uniform standards of review that will be applied equally.
- The program manager will determine whether that application is complete and the business is eligible under the program. SDC will attempt to work with applicants to verify or correct information before denying any application.
- Once all applications have been reviewed, SDC will notify approved and non-approved applicants.
- An applicant denied may appeal to the Borough Manager (in writing). Any appeal must be filed in writing by 5 p.m. that 10th calendar day after the day the applicant received notice from SDC.
- Upon closure of the appeal process, SDC will apply a formula to all approved applicants that provides each approved applicant with an equitable, proportionate share of the funding.
- SDC will establish the grant-sizing formula based on number of applicants, business loss and total expenses in 2020 after the application period closes so that actual data from the known pool of eligible applicants is considered in establishing the formula.

Awarding Funds

Businesses that are approved for funding must submit a w-9 and signed grant agreement to SDC before funds can be dispersed.

Once all signed documents are received, an applicants check will be mailed to the address provided on the application.
