The Commission decided to table Flowerbox, Benches, and Picnic Tables Application No. 16-98 in order to speak with the permitting official because of concern for encroachment on public right of way.

Commissioner Baldwin suggested to use a trim color with more contrast.

To amend Building Paint Approval Application No. 16-97 to change the building body to paint color Shutter Green #69; the building trim to dark chrome green #70 and the sash color to #2 cream.

To approve Building Paint Approval Application No. 16-97 as amended.

Motion passed by roll call vote of those present, 4 aye, 0 nay, 1 absent.

The Commission discussed the previously approved Sign Permit Application No. 16-99 with the applicant to make sure the paint colors on the sign reflects the changes made to the paint on the building.
