AN ORDINANCE OF THE MUNICIPALITY OF SKAGWAY, ALASKA AMENDING SECTION 12.01.040, APPOINTMENTS OF CHAPTER 12.01, PORT COMMISSION TO AMEND THE MEMBERSHIP OF THE PORT COMMISSION.

NOW THEREFORE BE IT ORDAINED AND ENACTED BY THE MUNICIPALITY OF SKAGWAY, ALASKA AS FOLLOWS:

<u>Section 1.</u> <u>Classification.</u> This ordinance is of a general and permanent nature and shall become a part of the Skagway Municipal Code.

<u>Section 2.</u> <u>Purpose.</u> To amend Chapter 12.01, Port Commission by removing the White Pass & Yukon Route Railroad as a liaison member.

<u>Section 3.</u> <u>Amendment.</u> Chapter 12.01, Skagway Port Commission is hereby amended (strike through) indicates text to be deleted from and (<u>bold</u>) indicates text added to the current code as follows:

12.01.040 Appointment

- A. Commissioners
 - 1. The mayor shall appoint Commissioners from among persons who either apply or are recommended for the positions, subject to confirmation of the assembly.
 - 2. Commissioners serve at the pleasure of the borough assembly and without compensation. The Mayor may recommend the removal of a commissioner, but the removal of a commissioner shall only occur by vote of the assembly in accordance with SMC 3.01.040(C).

B. Liaisons

- 1. Yukon Territory Liaison. The mayor shall appoint one (1) representative of the Yukon Territory, nominated by the Yukon Territory Government, to serve as a liaison between the Yukon Territory and the Commission. The Yukon Territory Liaison shall serve a three (3) year term. The Yukon Territory Liaison may serve more than one (1) term.
- 2. White Pass & Yukon Route Railroad Liaison. The mayor shall appoint one (1) representative of the White Pass & Yukon Route Railroad to serve as a liaison between the White Pass & Yukon Route Railroad and the Commission. The White Pass & Yukon Route Railroad Liaison shall serve a three (3) year term. The White Pass & Yukon Route Railroad Liaison may serve more than one (1) term.
- 3. 2. Assembly Liaison. The mayor shall appoint annually one (1) assembly member to serve as liaison between the assembly and the Commission. The Assembly Liaison may serve more than one (1) term.

4. 3. Liaison representatives may attend all meetings of the Commission. Liaison representatives shall have the privilege of the floor, but shall not have the right to vote on matters before the Commission.

<u>Section 4.</u> <u>Severability.</u> If any provision of this ordinance or any application of the ordinance to any person or circumstance is held invalid, the remainder of this ordinance and the application to other persons or circumstances shall not be affected.

<u>Section 5.</u> <u>Effective Date.</u> This ordinance shall become effective upon adoption of the Borough Assembly.
