AN ORDINANCE OF THE MUNICIPALITY OF SKAGWAY, ALASKA AMENDING THE FY14 CLINIC AND SALES TAX BUDGETS.

WHEREAS, the Clinic has donation funds in the Fish Wall and Heartbeat Trail fund reserve that will be used to offset the expense of lab equipment purchased by the Clinic in FY14; and

WHEREAS, the Clinic has been awarded two Department of Health and Social Services (DHSS) grants that should be reflected in the FY14 budget; and

WHEREAS, Public Works employee payroll expenses for work done at the Clinic should be reflected in the FY14 budget; and

WHEREAS, in FY14 the Clinic worked towards Meaningful Use status and through e-Health Network the Clinic qualified for partial funding to offset NextGen support/reporting expenses, and this revenue should be reflected in the budget; and

WHEREAS, the amount of funding needed from sales tax reserves has been reduced because of these Clinic budget amendments, and this needs to be reflected in the FY14 budget;

NOW THEREFORE, BE IT ORDAINED AND ENACTED BY THE MUNICIPALITY OF SKAGWAY, ALASKA AS FOLLOWS:

Section 1. Classification. This is a non-code ordinance.

Section 2. Purpose. To amend the FY14 Clinic and Sales Tax budgets to account for additional revenues and expenditures.

Section 3. Amendment. The FY14 Municipality of Skagway Budget is hereby amended as follows:
