## MUNICIPALITY OF SKAGWAY, ALASKA ORDINANCE NO. 11-27

AN ORDINANCE OF THE MUNICIPALITY OF SKAGWAY, ALASKA AMENDING CHAPTER 12.01 SKAGWAY PORT COMMISSION BY AMENDING SECTION 12.01.040 APPOINTMENT TO ADDRESS LIAISONS TO THE PORT COMMISSION.

**WHEREAS**, the Skagway Borough Assembly desires an ex-officio municipal member to serve as a liaison to the Port Commission; and

WHEREAS, an amendment to municipal code is required to allow an ex-officio municipal member to serve as a liaison to the Port Commission;

NOW THEREFORE BE IT ORDAINED AND ENACTED BY THE MUNICIPALITY OF SKAGWAY, ALASKA AS FOLLOWS:

<u>Section 1.</u> <u>Classification.</u> This ordinance is of a general and permanent nature and shall become a part of the Skagway Municipal Code.

<u>Section 2.</u> Purpose. To amend Chapter 12.01 Skagway Port Commission by amending section 12.01.040 Appointment.

**Section 3. Amendment.** The Skagway Municipal Code is hereby amended (strike through) indicates text to be deleted from and (**bold underscore**) indicates text added to the current code. Chapter 12.01 Skagway Port Commission is hereby amended as follows:

## 12.01.040 Appointment.

- A. Commissioners
  - The mayor shall appoint Commissioners from among persons who either apply or are recommended for the positions, subject to confirmation of the assembly.
  - 2. Commissioners serve at the pleasure of the borough assembly and without compensation. The Mayor may recommend the removal of a commissioner, which removal shall only occur by vote of the assembly in accordance with SMC 3.01.040(C).

## B. Liaisons

1. Yukon Territory Liaison. The mayor shall appoint one (1) representative of the Yukon Territory, nominated by the Yukon Territory Government, to serve as a liaison between the Yukon Territory and the Commission. The Yukon Territory Liaison shall serve a three (3) year term. The Yukon Territory Liaison may serve more than one (1) term.

- 2. Assembly Liaison. The mayor shall appoint annually one (1) assembly member or ex-officio municipal member to serve as liaison between the assembly and the Commission. The Assembly Liaison may serve more than one (1) term.
- 3. Liaison representatives may attend all meetings of the Commission. Liaison representatives shall have the privilege of the floor, but shall not have the right to vote on matters before the Commission.

<u>Section 4.</u> <u>Severability.</u> If any provision of this ordinance or any application thereof to any person or circumstance is held invalid, the remainder of this ordinance and the application to other persons or circumstances shall not be affected thereby.

<u>Section 5.</u> <u>Effective Date.</u> This ordinance shall become effective immediately upon adoption.
