MUNICIPALITY OF SKAGWAY, ALASKA ORDINANCE NO. 14-21

AN ORDINANCE OF THE MUNICIPALITY OF SKAGWAY, ALASKA AMENDING THE FY15 SALES TAX FUND, GENERAL FUND, CLINIC FUND, CPV EXCISE TAX FUND, WATER/SEWER FUND, AND SMALL BOAT HARBOR FUND BUDGETS.

WHEREAS, the Clinic applied for but did not receive a grant for behavioral health services; and

WHEREAS, at its April 3, 2014, meeting, the Skagway Borough Assembly expressed its support to municipally fund behavioral health services if no grant was awarded; and

WHEREAS, the HRSA 330 grant that provides funding to the Clinic was increased for FY15, and the budget should be amended to reflect the increase and the subsequent reduction in Sales Tax funding required; and

WHEREAS, the Utility Rate Study was initially budgeted for in FY14 but the project was not completed during that time; funding is needed in FY15 for the project; and

WHEREAS, various costs associated with Internet use and credit card fees must be provided for in the FY15 budget;

NOW THEREFORE, BE IT ORDAINED AND ENACTED BY THE MUNICIPALITY OF SKAGWAY, ALASKA AS FOLLOWS:

Section 1. <u>Classification</u>. This is a non-code ordinance.

Section 2. <u>Purpose</u>. To amend the FY15 Sales Tax Fund, General Fund, Clinic Fund, CPV Excise Tax Fund, Water/Sewer Fund, and Small Boat Harbor Fund budgets to account for additional revenues and expenditures.

Section 3. <u>Amendment</u>. The FY15 Municipality of Skagway Budget is hereby amended as follows:
