### RESOLUTION NO. 08-09R

**A RESOLUTION OF THE MUNICIPALITY OF SKAGWAY, ALASKA AMENDING THE COMMERCIAL USER FEES FOR CLARIFICATION AT THE SKAGWAY SMALL BOAT HARBOR AND REPEALING RESOLUTION NO. 07-12R.**

**WHEREAS**, The Municipality recognizes the importance of the Small Boat Harbor and year-round economic development; and

**WHEREAS**, It is necessary to amend the Commercial Use Fees for clarification;

**NOW, THEREFORE, BE IT RESOLVED** by the Assembly of the Municipality of Skagway that the following fee schedule for the Skagway Small Boat Harbor is hereby adopted:

**Commercial Use Fees:**

Commercial Use of Harbor ~~\$1.00 per revenue passenger tariff for all commercial vessels (including fishing charters and kayaks) loading or unloading passengers in the Skagway Small Boat Harbor.~~

**All commercial vessels, including but not limited to fishing charters and kayaks, shall pay \$2.00 per revenue passenger as a tariff for loading and unloading passengers at the Skagway Small Boat Harbor. If the vessel only loads passengers at the Harbor, or only unloads passengers at the Harbor, the fee shall be \$1.00 per passenger.**

Barge Fees for Ferry Float \$ .50 per foot per tie up (barge and tug length) for all barges loading or unloading at the Ferry Float unless otherwise covered in a Municipal staging area or tidelands lease.

Cruise Vessel Docking Fee at Ferry Float \$200

**Non-Commercial Use Fees:**

Annual Moorage	\$ 12.00/ft.; includes boat launch ramp fee
Transient Moorage	\$ .30/ft. per day or \$3.00/ft. per month
Long-term Storage	\$ .20/sq. ft. per month
Kayak Storage	\$ 7.00 per month per vessel
Live a Board	Single Family Residential Utility Rate
Pressure Washer	\$ 15.00/hr.
Grid Fee	\$ 15.00 per tide
Haul-out Fee	\$ 200.00/rt.
Boat Launch Ramp Fee	\$ 5.00 per launch-includes all boats, kayaks, canoes, etc.; or \$ 25.00 per year per boat
Waiting List Fee	\$ 50.00 initial fee to get on list \$ 10.00 annual fee (This will not be renewed automatically. Bills will not be sent. It will be the responsibility of the individual to contact the harbormaster if they wish to remain on the list, and pay the fee. Failure to do so will result in removal from the waiting list)
Harbor Crane Use Fee	\$ 20.00 per hour with a ½ hour minimum; or \$50.00 annual fee
Transient Electrical Rates	\$ 7.50 per day for 30 amp; and

Transient Billing Surcharge	\$ 12.50 per day for 50 amp. \$ 10.00 surcharge will be added to any transient fee not paid prior to departure of the transient vessel.
Senior Citizen Discount	15% will apply to annual moorage fees paid by residents of Skagway who are age 65 or older for personal pleasure craft.

**BE IT FURTHER RESOLVED**, that Resolution No. 05-22R is hereby repealed and replaced by this resolution.

**EFFECTIVE DATE:** the Fees shall be effective immediately upon adoption.
