A RESOLUTION OF THE MUNICIPALITY OF SKAGWAY, ALASKA AMENDING COMMERCIAL USE AND NON-COMMERCIAL USE FEES FOR THE SKAGWAY SMALL BOAT HARBOR, AND REPEALING RESOLUTION NO. 16-06R.

WHEREAS, It is necessary to adjust the Commercial and Non-Commercial Use Fees at the Small Boat Harbor:

NOW, THEREFORE, BE IT RESOLVED by the Assembly of the Municipality of Skagway that the following fee schedule for the Skagway Small Boat Harbor is hereby adopted:

Commercial Use Fees:

Commercial Use of Harbor

All commercial vessels, including but not limited to fishing charters and kayaks, shall pay the following rates per revenue passenger as a tariff for loading and unloading passengers at the Skagway Small Boat Harbor:

\$ 1.80 from April 1, 2016 through March 31, 2017-;

\$ 1.84 from April 1, 2017 through March 31, 2018;

\$ 1.88 from April 1, 2018 through March 31, 2019;

1.92 from April 1, 2019 through March 31, 2020;

\$ 1.96 from April 1, 2020 through March 31, 2021.

If the vessel only loads passengers at the Harbor, or only unloads passengers at the Harbor, the fee shall be as follows per passenger:

\$ 0.90 from April 1, 2016 through March 31, 2017-;

5 0.92 from April 1, 2017 through March 31, 2018;

0.94 from April 1, 2018 through March 31, 2019;

\$ 0.96 from April 1, 2019 through March 31, 2020;

\$ 0.98 from April 1, 2020 through March 31, 2021.

Barge Fees for Ferry Float

\$0.50 per foot per day or \$5.00 per foot per month (barge and tug length) for all barges loading or unloading at the Ferry Float unless otherwise covered in a Municipal staging area or tidelands lease.

Commercial Launch Ramp \$

\$ 20.00 daily

\$ 300.00 annual

Cruise Vessel Docking Fee at Ferry Float \$200.00

Annual Moorage \$ 14.00 per foot from April 1, 2016 through March 31, 2017;

(includes boat launch ramp fee) \$ 14.10 per foot from April 1, 2017 through March 31, 2018;

\$ 14.20 per foot from April 1, 2018 through March 31, 2019; \$ 14.30 per foot from April 1, 2019 through March 31, 2020; \$ 14.40 per foot from April 1, 2020 through March 31, 2021.

Transient Moorage \$0.40 per ft/day and \$4.00 per ft. per month from April 1, 2016

through March 31, 2017;

\$0.44 per ft./day and \$4.40 per ft./month from April 1, 2017

through March 31, 2018;

\$0.48 per ft./day and \$4.80 per ft./month from April 1, 2018

through March 31, 2019;

\$0.52 per ft./day and \$5.20 per ft./month from April 1, 2019

through March 31, 2020;

\$0.56 per ft./day and \$5.60 per ft./month from April 1, 2020

through March 31, 2021.

Long-term Storage \$ 0.20/sq. ft. per month; 250 sq. ft. minimum Kayak Storage \$ 7.00 per month per vessel

Live a Board Single Family Residential Utility Rate

Pressure Washer \$ 20.00/hr.; 1 hr. minimum through March 31, 2017;

\$ 25.00/hr.; 1 hr. minimum starting April 1, 2017.

Grid Fee \$ 15.00 per tide

Haul-out Fee Clemar/Sealift \$ 200.00/rt. From water to stands and back Haul-out Fee Clemar/Sealift \$ 150.00/rt.; Stay on trailer 3 hr. max

Haul-out Fee Clemar/Sealift \$ 120.00/hr.; 1 hr. min. yard move

Haul-out w/Flat bed Truck \$ 60.00/hr.; 1 hr. minimum

Boat Launch Ramp Fee \$ 10.00 per launch-includes all boats, kayaks, canoes, etc.; or

\$ 50.00 per year per boat

Waiting List Fee \$ 50.00 initial fee to get on list

\$ 10.00 annual fee

(This will not be renewed automatically. Bills will not be sent. It will be the responsibility of the individual to contact the harbormaster if they wish to remain on the list, and pay the fee.

Failure to do so will result in removal from the waiting list) \$ 20.00 per hour with a ½ hour minimum; or \$50.00 annual fee

Harbor Crane Use Fee Boat Maintenance Building:

Bay Rental 4/1-9/30 \$ 30.00 per day. Bay Rental 10/1-3/31 \$ 45.00 per day.

Cleaning Deposit \$ 500.00 per rental period.

Transient Electrical Rates \$ 10.00 per day for 30 amp; and \$ 20.00 per day for 50 amp.

Senior Citizen Discount 15% will apply to annual moorage fees paid by residents of Skagway who are age 65 or older for personal pleasure craft.
