RESOLUTION NO. 17-20R

A RESOLUTION OF THE MUNICIPALITY OF SKAGWAY, ALASKA ESTABLISHING NEW FEES FOR THE SKAGWAY RECREATION CENTER.

WHEREAS, the Recreation Board met on June 6, 2017, and voted unanimously to propose a new Recreation Center fee proposal to the Assembly for consideration; and

WHEREAS, the Recreation Board recognizes that the current fee structure has not changed since FY03, yet operating costs have increased and continue to do so annually; and


WHEREAS, the Recreation Center facility has developed substantially over the past 14 years with a greater number of services offered, an increase in hours of operation during summer and winter months, an increase in the amount of equipment available, and a higher quality of equipment available for use;

NOW, THEREFORE BE IT RESOLVED, by the Borough Assembly of the Municipality of Skagway that the fees as proposed in Attachment A titled, "SRC New Membership Fee Proposal" be approved and established as the new Skagway Recreation Center fees; and

BE IT FURTHER RESOLVED, that the new fees as proposed in Attachment A shall take effect on July 1, 2017; and

BE IT FURTHER RESOLVED, that the Recreation Board will revisit the Recreation Center fees yearly and make recommendations to the Assembly.
