A RESOLUTION OF THE MUNICIPALITY OF SKAGWAY, ALASKA REPEALING RESOLUTION NO. 15-37R, AND AMENDING PARKING ZONES.

NOW, THEREFORE BE IT RESOLVED, that Resolution No. 15-37R is hereby repealed and replaced with the following; and

BE IT FURTHER RESOLVED, that the Skagway Borough Assembly establishes the following modifications to parking zones, strike through indicates text deleted and **bold/underline** indicates text added to the current regulations for the Municipality of Skagway to become effective upon adoption:

- A. Restricted Parking, Timed Parking, Loading Zones and No Parking Zones. The following restricted parking zones are established and, unless otherwise noted, shall be in effect daily during the period from **May 1**st to October 1st from 8:00 a.m. to 6:00 p.m.
- 1. One hour parking:
 - a. East and west side of Broadway from 2nd Avenue to 7th Avenue unless designated otherwise.
 - b. North side of 6th Avenue from Spring Street toward Broadway in front of municipally owned lots (Mollie Walsh Park).
 - c. South side of 2nd Avenue between State Street and Broadway.
 - d. West side of Broadway beginning at the alley between 7th Avenue and 8th Avenue continuing south for 20 feet.
 - e. West side of Broadway beginning 52 feet from the intersection of Broadway and 2nd Avenue continuing south 48 feet.

2. 20-minute parking:

- a. West side of Broadway 100 feet south from 7th Avenue to the alley between 6th Avenue and 7th Avenue.
- b. North side of 4th Avenue beginning 50 feet from the corner of Spring Street and continuing west for 50 feet.
- 3. Loading zones:
 - North side of 2nd Avenue east from Broadway commencing at the lot line between Lots 8 and 9 of Block 35 and continuing east for 125 feet.
 - b. North side of 2nd Avenue beginning at the lot line between lot 10 and lot 11, Block 34 east for 92.3 feet. In effect 8:00 a.m. to 8:00 p.m.
 - c. East side of Broadway from the alley between 5th Avenue and 6th Avenue to 6th Avenue. In effect 8:00 a.m. to 10:00 p.m.
 - d. West side of Congress Way between the north and south driveways of the south small boat harbor parking lot.
 - e. North and south sides of 3rd Avenue for 150 feet west beginning at the corner of Spring Street and 3rd Avenue loading zone (Westmark). In effect 8:00 a.m. to 12:00 noon.
 - f. South side of 7th Avenue beginning 20 feet from the corner of Broadway & 7th Avenue and continuing west for 100 feet. In effect 9:00 a.m. until 5:00 p.m.
 - g. North side of 6th Avenue beginning at the east corner of Lot 9, Block 3 continuing west for 30 feet.
 - h. East side of Broadway beginning at 7th Avenue continuing north for 50 feet.

- i. East side of Broadway for 50 feet south of corner of 2nd Avenue.
- j. South side of 2nd Avenue beginning 20 feet from the corner of Broadway & 2nd Avenue and continuing east for 95 feet.
- k. South side of 5th Avenue beginning 20 feet from the corner of Broadway & 5th Avenue and continuing west for 50 feet.
- I. Southwest end of the turnaround where Congress Way terminates at the Railroad dock Handicapped loading only.
- m. West side of Spring Street beginning at the alley between 2nd Avenue and 3rd Avenue and continuing south for 40 feet.

4. SMART Stop zones:

- a. East side of Broadway for 75 feet south from 3rd Avenue (ending at the northern side of the Skagway News Depot entrance).
- b. West side of Broadway from the corner of 5th Ave. and proceeding north 80 feet.
- c. West side of Broadway beginning at 3rd Avenue and proceeding south for 75 feet.
- d. East side of Broadway from the alley between 5th and 6th Avenues and proceeding south 75 feet.
- e. East side of Spring Street and 7th Avenue in front of the Museum entrance into the McCabe Building.
- f. West side of Broadway beginning at the corner of 7th Avenue proceeding north 80 feet.
- g. West side of State Street beginning at the corner of 9th Avenue proceeding north 60 feet.
- h. West side of Congress Way beginning 45 feet from the southeast corner of the public bathrooms going south 125 feet along the circular turnaround.
- i. Beginning near the power pole extending south about 100 feet across from the Southern Pedestrian Access Bridge at the Ore Terminal Dock.
- j. North side of 2nd Avenue beginning at the corner of Spring Street proceeding west for 75 feet.
- k. South side of 2nd Avenue beginning 115 feet from the corner of Broadway & 2nd Avenue and continuing east for 94 feet.
- I. East side of Broadway beginning at the south corner of 14th Avenue and continuing south for 50 feet.

Oversized vehicles:

- a. East and west side of Broadway from 1st Avenue to 7th Avenue no vehicles in excess of 19 feet in length.
- b. North side of 7th Avenue beginning 20 feet from the intersection of Broadway Street and 7th Avenue continuing east 130 feet no vehicles in excess of 19 feet in length.

6. No Parking at any time:

- a. No parking south of the alley between 1st Avenue and 2nd Avenue on the East and West side of Broadway.
- b. Both sides of Congress Way north to the intersection at the railroad tracks unless otherwise designated.
- c. Beginning at the railroad tracks in the alley between 1st and 2nd Avenue continuing north for 50 feet on the East and West side of Broadway, no parking, stopping or standing.
- d. West side of Broadway beginning at the alley between 7th and 8th Avenue continuing north to 8th Avenue.
- e. East side of Broadway beginning at the intersection of 5th Avenue and Broadway and continuing north 25 feet.

- f. West side of Broadway 30 feet south of the alley between 2nd Avenue and 3rd Avenue in front of AB Hall.
- g. East side of Spring Street from 3rd Avenue to 2nd Avenue.
- h. West side of Spring Street beginning at the corner of 2nd Avenue and Spring Street and continuing north for 60 feet.
- i. West side of Broadway beginning at the alley between 2nd Avenue and 3rd Avenue continuing north for 25 feet.

7. Other Restrictions:

- a. South small boat harbor parking lot, west of the loading zone by the south ramp to the small boat harbor, small boat harbor parking only. Parking is for small boat harbor users only and not to be used for commercial passenger vehicles. Unless otherwise noted this parking is limited to 24 hours.
- b. Dyea Shuttle bus zone only: beginning 12 feet south of the intersection of Broadway Street and 2nd Avenue continuing south for 40 feet.

B. Restricted Parking, Timed Parking, Loading and Drop Off Zones. The following restricted parking zones are established to be in effect year round.

1. Restricted Parking:

- a. One parking space on the north side of City Hall parking lot Handicapped parking.
- b. South side of 6th Avenue for 20 feet west from the corner of Broadway, one car length- Handicapped parking.
- c. North and south side of 5th Avenue for 100 feet west of State Street No Parking, Fire Department Personnel Only.
- d. East and West side of State Street south 100 feet from the Alley between 5th Avenue and 6th Avenue No Parking.
- e. South side of 5th Avenue for 150 feet west from Spring Street No Parking.
- f. South small boat harbor parking lot, first two parking spaces on the south end Handicapped parking.
- g. West side of Main Street commencing at the north side of the alley between 4th Avenue and 5th Avenue and continuing north for 28 feet ending 72 feet from the corner of 5th Avenue Handicapped parking.

2. Timed Parking:

- a. West side of Broadway for 100 feet north of corner of 6th Avenue 20 minute parking.
- b. East side of Broadway for 100 feet north of corner of 6th Avenue 20 minute parking.
- c. East side of Broadway from 2nd Avenue to 3rd Avenue excluding the SMART Stop 20 minute parking.
- d. South side of 2nd Avenue from State Street commencing 12 feet from the curb cut and continuing to the lot line between Lots 4 and 5, Block 37 20 minute parking.
- e. South side of 2nd Avenue beginning 191 feet from the corner of Broadway & 2nd Avenue and continuing east for 59 feet 20 minute parking.
- f. North side of 2nd Avenue east from Broadway (except for the curb cut) commencing 30-feet from the stop sign and continuing to the lot line between Lots 8 and 9 of Block 35 20 minute parking restricted to vehicles of 19 feet or less.
- g. South side of 5th Avenue commencing from the corner of State Street and continuing east for 230 feet ending 70 feet from the corner of Broadway 20 minute parking.
- h. South small boat harbor parking lot, north three parking spaces is limited to 30 minute parking.

- North side of 5th Avenue commencing 20 feet from the corner of State Street and continuing east for 260 feet ending 20 feet from the corner of Broadway 20 minute parking.
- j. North side of 3rd Avenue commencing 100 feet from the corner of State Street and continuing east 200 feet to the corner of Broadway 1 hour parking.
- 3. No Parking at any time:
 - a. South side of 2nd Avenue from State Street commencing at the curb cut and continuing for 12 feet.
 - b. East and west side of State Street within 20 feet of all intersections between 1st Avenue and 22nd Avenue.
 - c. East and west side of Broadway Street from the intersection of 14th Avenue and continuing north for 120 feet to the southeast corner of Lot 1, Block 89 and the southwest corner of Lot 6, Block 88.
- C. Loading zones shall be available for use by all vehicles (both private and commercial) unless otherwise designated.
- 1. Loading zones time limits
 - a. Active loading/unloading of freight or passengers for up to 30 minutes.
