## **MUNICIPALITY OF SKAGWAY, ALASKA**

### **RESOLUTION NO. 18-07R**

**A RESOLUTION OF THE MUNICIPALITY OF SKAGWAY, ALASKA COMMITTING AND RESTRICTING \$1,504,946 OF COMMERCIAL PASSENGER VESSEL EXCISE TAX FUNDS FOR REPAYMENT OF A STATE OF ALASKA LOAN TO FUND THE WOODSTAVE WATER TANK PROJECT, AND REPEALING RESOLUTION NO. 17-14R.**

**WHEREAS**, the Municipality must construct an additional domestic drinking water well and water tank to avert a drop in available water to dangerously low levels; and

**WHEREAS**, at its meeting of July 7, 2016, the Borough Assembly determined that the reason a new drinking water well and water tank are needed by the community is due to the enormous demand for water each day by the cruise ships and their passengers; and

**WHEREAS**, this determination is evidenced by the alarming drop in water tank levels from full, with all wells pumping, only when cruise ships arrive and start taking on water; these levels recover when cruise ships leave port as shown on the attached tank level charts, noted as Attachment A; and

**WHEREAS**, this determination is further evidenced by the expert testimony of experienced municipal staff; and

**WHEREAS**, it is acknowledged that the Municipality has ample water pumping capacity and tank storage when cruise ships and their passengers are not in town; and

**WHEREAS**, the State of Alaska Department approved loan ACWF#785021 for the Municipality of Skagway in the principal amount of \$1,297,340 to construct a woodstave water tank, which will directly benefit the cruise ships and the cruise ship passengers, with a total debt repayment amount of \$1,504,946; and

**WHEREAS**, the construction of the woodstave water tank is solely to provide the enormous demand for water by the cruise ships and their passengers; and

**WHEREAS**, the Skagway Borough Assembly agrees that Cruise Passenger Vessel (CPV) funds would be appropriately used to make debt payments on this loan;

**NOW THEREFORE BE IT RESOLVED**, that the Municipality of Skagway commits \$1,125,800 of Cruise Ship Passenger Vessel (CPV) funds to be used for total debt retirement of the State of Alaska loan for the Woodstave Water Tank project;

**BE IT FURTHER RESOLVED**, that this total amount shall be considered a restriction on the balance in the municipal CPV fund and such encumbrance shall only be reduced as the remaining balance decreases after payments or in the instance of any forgiveness of

debt by the State of Alaska; this restricted amount shall not be used, appropriated or committed to any other project or need; and


**BE IT FURTHER RESOLVED**, that Resolution No. 17-14R is hereby repealed.
