## MUNICIPALITY OF SKAGWAY, ALASKA ORDINANCE NO. 18-08

AN ORDINANCE OF THE MUNICIPALITY OF SKAGWAY, ALASKA AMENDING THE FY18 GENERAL FUND AND CAPITAL PROJECTS FUND BUDGETS TO ACCOUNT FOR PROJECTED REVENUES AND EXPENSES RELATED TO MUNICIPAL RECREATIONAL VEHICLE PARKS.

**WHEREAS**, the Municipality of Skagway will be actively managing both the Pullen Creek RV Park and the Garden City RV Park; and

**WHEREAS,** Administration has estimated expenses related to RV park management, including the contract for park management and the cost of capital projects for the upgrades of both parks; and

**WHEREAS,** Administration has estimated the projected revenues from RV park usage; and

**WHEREAS**, the FY18 budget must be amended to account for estimated revenues and expenditures related to municipal RV park management;

## NOW THEREFORE, BE IT ORDAINED AND ENACTED BY THE MUNICIPALITY OF SKAGWAY, ALASKA AS FOLLOWS:

**Section 1.** Classification. This is a non-code ordinance.

**Section 2.** Purpose. To amend the FY18 General Fund and Capital Projects budgets to account for revenues and expenditures related to the management of municipal RV parks.

**Section 3.** Amendment. The FY18 Municipality of Skagway Budget is hereby amended as follows:
