## AN ORDINANCE OF THE MUNICIPALITY OF SKAGWAY, ALASKA AMENDING THE FY20 GENERAL FUND AND SALES TAX FUND BUDGETS TO ACCOUNT FOR THE COST OF VESSEL REMOVAL FROM THE DYEA FLATS, PARKING LOT LEASES, AND REALLOCATION OF TITLE III FOREST RECEIPTS.

WHEREAS, \$114,223 of Title III forest receipts cannot be used on schools as budgeted, and therefore must be moved into a holding account until they are reallocated for eligible projects; and

**WHEREAS**, funding must be included in the FY20 for the cost of removing a vessel from the Dyea Flats, to be reimbursed by the vessel owner; and

**WHEREAS**, the Westmark and White Pass parking lot lease expense was not included in the FY20 budget and must be added;

## NOW THEREFORE, BE IT ORDAINED AND ENACTED BY THE MUNICIPALITY OF SKAGWAY, ALASKA AS FOLLOWS:

Section 1. <u>Classification</u>. This is a non-code ordinance.

**Section 2.** <u>Purpose</u>. To amend the FY20 General Fund and Sales Tax Fund budgets to account for the cost of vessel removal from the Dyea Flats, parking lot leases, and reallocation of Title III forest receipts.

**Section 3.** <u>Amendment</u>. The FY20 Municipality of Skagway Budget is hereby amended as follows:
