A RESOLUTION OF THE MUNICIPALITY OF SKAGWAY SUPPORTING THE ALASKA MARINE HIGHWAY SYSTEM AND DAY BOAT SERVICE IN LYNN CANAL.

WHEREAS, our region is coastal in nature and our economies have evolved around reliable and predictable patterns of marine transportation; and

WHEREAS, state ferries deliver people, food, health care, supplies, and equipment to coastal communities throughout the state, with economic impacts far beyond the area in which they operate; and

WHEREAS, many Skagway business owners depend on reliable ferry service for revenue, especially those open year-round; and

WHEREAS, residents of Skagway, Haines, and many other communities depend on the marine highway for safe and reliable winter travel, particularly for health care needs; and

WHEREAS, elderly and residents with physical challenges are particularly dependent upon the marine highway for medical needs that cannot be provided in small communities; and

WHEREAS, the state's financial woes coupled with the aging fleet of vessels have combined to form the perfect storm for the Alaska Marine Highway System (AMHS); and

WHEREAS, the recent suspension of ferry service has caused great hardship for residents, schools, businesses and coastal economies; and

WHEREAS, Northern Lynn Canal provides an essential link between the State Capital and the two road heads out of Haines and Skagway; and

WHEREAS, for many decades the Golden Circle Tour has been a highly successful joint marketing effort on behalf of Haines, Skagway, Haines Junction, and Whitehorse; and

WHEREAS, the Alaska ferries are an essential component of the independent visitor industry and support a robust visitor economy for the communities of Haines, Skagway, and Juneau; and

WHEREAS, the Northern Lynn Canal route generates significant revenue for AMHS; and

WHEREAS, Governor Dunleavy's consultant report by Northern Economics, "Alaska Marine Highway System Economic Reshaping Report," recommends optimizing revenues and efficiencies whenever possible; and
