RESOLUTION NO. 20-33R**

**A RESOLUTION OF THE MUNICIPALITY OF SKAGWAY, ALASKA WAIVING COMMERCIAL UTILITY FEES FROM OCTOBER 1, 2020 THROUGH MARCH 31, 2021, TO MITIGATE THE IMPACTS OF THE COVID-19 PANDEMIC ON SKAGWAY BUSINESSES.**

**WHEREAS**, on March 16, 2020, the Municipality of Skagway declared an emergency based on the risk to the public posed by the global COVID-19 pandemic and the substantial adverse economic impacts to Skagway residents, which was confirmed by the Assembly on March 19, 2020; and

**WHEREAS**, Skagway businesses rely upon the tourism industry for financial stability; and

**WHEREAS**, the widespread cancellation of cruises to Alaska will have a detrimental impact on Skagway businesses; and

**WHEREAS**, secondary impacts to the local economy due to COVID-19 travel restrictions and health mandates will be devastating, with an estimated total community revenue loss of approximately \$160 million for the 2020 season; and

**WHEREAS**, the Municipality of Skagway wishes to waive commercial water, sewer, and solid waste disposal fees for businesses to mitigate the impacts of the COVID-19 pandemic on the financial stability of Skagway businesses;

**NOW THEREFORE BE IT RESOLVED THAT** the Borough Assembly of the Municipality of Skagway waives the following commercial utility fees for the period of October 1, 2020 through March 31, 2021:


