MUNICIPALITY OF SKAGWAY, ALASKA ORDINANCE NO. 20-19

AN ORDINANCE OF THE MUNICIPALITY OF SKAGWAY, ALASKA AMENDING THE FY20.5 SALES TAX FUND, CPV EXCISE TAX FUND, AND GENERAL FUND BUDGETS TO ACCOUNT FOR THE ACCOUNTS RECEIVABLE POSITION, INCINERATOR ANALYSIS PROJECT, AND DAYCARE FUNDING.

WHEREAS, at its meeting of August 6, 2020 the Assembly adopted Resolution No. 20-31R, which allowed for the hiring of an Accounts Receivable position in FY20.5 (July 31, 2020 – December 31, 2020), and this expense must be reflected in the budget; and

WHEREAS, the Manager and Finance Committee chair are authorized to approve funding for for-profit daycares in FY20.5 through the Skagway Deal Program for a total expense of \$25,000, and this must be reflected in the budget; and

WHEREAS, the expenses for the Accounts Receivable position and for-profit daycare funding will be funded from Sales Tax; and

WHEREAS, the Incinerator Analysis project was delayed from FY20 and must be reflected in the FY20.5 budget, to be funded from CPV Excise Tax;

NOW THEREFORE, BE IT ORDAINED AND ENACTED BY THE MUNICIPALITY OF SKAGWAY, ALASKA AS FOLLOWS:

Section 1. <u>Classification</u>. This is a non-code ordinance.

Section 2. <u>Purpose</u>. To amend the FY20.5 Sales Tax Fund, CPV Excise Tax Fund, and General Fund Budgets to account for an Accounts Receivable position, Incinerator Analysis Project, and daycare funding.

Section 3. <u>Amendment</u>. The FY20.5 Municipality of Skagway Budget is hereby amended as follows:
