## MUNICIPALITY OF SKAGWAY, ALASKA ORDINANCE NO. 21-06

AN ORDINANCE OF THE MUNICIPALITY OF SKAGWAY, ALASKA AMENDING THE FY21 GENERAL FUND, CAPITAL PROJECTS FUND, AND SALES TAX FUND BUDGETS TO PROVIDE FUNDING FOR THE ESTABLISHMENT AND IMPLEMENTATION OF AN ECONOMIC STIMULUS PROGRAM.

**WHEREAS,** the FY21 was developed estimating 25-percent of normal revenue, and the FY21 outlook has been revised to anticipate six-percent of normal revenue at best; and

**WHEREAS**, with expenditures as adopted in the FY21 budget, the Sales Tax and Excise Tax reserves are anticipated to be at approximately \$5 million and \$11.5 million, respectively, at the end of the year; and

**WHEREAS**, due to ongoing impacts from the lack of cruise visitors to Skagway in 2021, the Municipality acknowledges that it can expend more of its reserve funding to support the community with employment, programs, and projects that will sustain it until the anticipated return of cruise ships to Alaska in 2022; and

WHEREAS, allocating at least \$500,000 more in the FY21 budget to support employment, programs, and community projects would reduce reserve levels to approximately \$4.5 million in Sales Tax at the end of 2021, which is still a healthy reserve amount; and

**WHEREAS,** the Municipality wishes to support the economic and mental health of its community by establishing and implementing an Economic Stimulus Program, funded from Sales Tax reserves; and

**WHEREAS**, the Economic Stimulus Program would provide funding for the hiring of four full-time municipal positions with benefits, 12 seasonal positions without benefits, the Skagway Food Bank, a Positive Graffiti Mural program, and five projects for local contractors;

## NOW THEREFORE, BE IT ORDAINED AND ENACTED BY THE MUNICIPALITY OF SKAGWAY, ALASKA AS FOLLOWS:

Section 1. <u>Classification</u>. This is a non-code ordinance.

**Section 2.** <u>Purpose</u>. To amend the FY21 General Fund, Capital Projects Fund, and Sales Tax Fund budgets to provide funding for the establishment and implementation of an Economic Stimulus Program.

**Section 3.** <u>Amendment</u>. The FY21 Municipality of Skagway Budget is hereby amended as follows:
