WHEREAS, James Higgins applied for Conditional Use Permit, Application No. 2024017 within the Residential General Zone, Request to Convert Garage to Accessory Dwelling Unit; and

WHEREAS, the Planning & Zoning Commission found that per SMC 19.04.060(B)(3)(a) the requested conditional use will not protect the public health, safety, and welfare because of fire safety standards; and

WHEREAS, the Planning & Zoning Commission found that per SMC 19.04.060(B)(3)(b) the requested conditional use will not permanently or substantially injure the lawful use of the neighboring properties or uses; and

WHEREAS, the Planning & Zoning Commission found that per SMC 19.04.060(B)(3)(c) the requested conditional use will not generally be in harmony with the comprehensive plan, coastal management plan, and other officially adopted plans due to zoning regulations and setback requirements; and

WHEREAS, the Planning & Zoning Commission found that per SMC 19.04.060(B)(3)(d) the requested conditional use will not substantially decrease the value of or be out of harmony with property in the neighboring area;

NOW THEREFORE BE IT RESOLVED by the Planning & Zoning Commission of the Municipality of Skagway, Alaska that Conditional Use Permit Application No. 2024017 from James Higgins; Lots 9 & 10 Block 76, in the Residential General Zoning District is denied.
