**MUNICIPALITY OF SKAGWAY, ALASKA  
RESOLUTION NO. 23-24R**

**A RESOLUTION OF THE MUNICIPALITY OF SKAGWAY, ALASKA AMENDING RESOLUTION NO. 19-27R, TO AMEND PARKING ZONES.**

**WHEREAS**, the Assembly Public Safety Committee met on May 16, 2023 and recommended amendments to Resolution 19-27R.

**NOW, THEREFORE BE IT RESOLVED**, that Resolution No. 19-27R is hereby amended:

**A. No Parking Zones.**

1. On the east side of Spring Street, beginning 20 feet from the north corner of Second Avenue and extending north 20 feet.
2. On the east side of Spring Street, beginning at the corner of Third Avenue and extending south 30 feet.
3. On the west side of Broadway, beginning 75 feet from the north corner of Second Avenue and extending north 25 feet.
- ~~4. The north 40 feet of Lots 7 – 9, Block 37.~~
54. The south side of Congress Way beginning at the southeast corner of Spring Street extending east to the railroad tracks; and the north side of Congress Way beginning 100 feet east from the northeast corner of Spring Street extending east to the railroad tracks, unless otherwise designated.
65. Both sides of Broadway beginning at the intersection of Fourteenth Avenue and extending 120 feet north.

**B. Loading Zones.** Loading Zones are areas in which active loading and unloading of freight or passengers may occur for up to 30 minutes.

1. Second Avenue:
  - a. North side, beginning 20 feet from the west corner of Broadway and extending 130 feet west.
  - b. North side, beginning 50 feet from the east corner of Broadway and extending 200 feet east.
  - c. South side, beginning 20 feet from the east corner of Broadway and extending 130 feet east.
  - d. South side, beginning 100 feet from the west corner of Broadway and extending 100 feet west.
2. Third Avenue:
  - a. North side, beginning 20 feet from the corner of Spring Street and extending 180 feet west.
  - b. South side, beginning 30 feet from the corner of Spring Street and extending 170 feet west.
3. Fifth Avenue:
  - a. South side, beginning 30 feet from the west corner of Broadway and extending 70 feet west.

4. Seventh Avenue:
  - a. South side, beginning 30 feet from the west corner of Broadway and extending 100 feet west.
  - b. South side, beginning 20 feet from the east corner of Broadway and extending 130 feet east.
5. Broadway Street:
  - a. East side, beginning 20 feet from the south corner of Sixth Avenue and extending 80 feet south.
6. Congress Way:
  - a. West side, between the north and south driveways of the south Small Boat Harbor parking lot.
  - b. West side, extending for the length of the Sea Walk parking lot island.
7. Spring Street:
  - a. West side, beginning 30 feet from the north corner of Second Avenue and extending 45 feet north.

C. ~~SMART~~ **Skagway Municipal Authority Regional Transit Zones.**

1. Second Avenue:
  - a. South side, beginning 150 feet from the east corner of Broadway and extending 100 feet east.
  - b. North side, beginning 20 feet from the west corner of Spring Street and extending 35 feet west.
  - c. North side, beginning 20 feet from the east corner of Spring Street and extending 80 feet east.
2. Broadway Street:
  - a. West and East sides, beginning 20 feet from the south corners of Third Avenue and extending 80 feet south.
  - b. West and East sides, beginning 20 feet from the north corners of Fifth Avenue and extending 80 feet north.
  - c. West side, beginning 20 feet from the north corner of Seventh Avenue and extending 80 feet north.
  - d. ~~East side, beginning 20 feet from the south corner of Fourteenth Avenue and extending 80 feet south.~~
3. East side of Spring Street and Seventh Avenue in front of the Museum entrance to the McCabe Building.
4. West side of Congress Way, beginning 45 feet from the southeast corner of the public bathrooms and extending 125 feet south along the turnaround.
5. At the Ore Terminal Dock, beginning near the power pole and extending 100 feet across from the southern pedestrian access bridge at the Ore Dock.
6. ~~West side of State Street beginning 20 feet from the north corner of Ninth Avenue and extending 60 feet north.~~

D. ~~Dyea~~ **Shuttle and/or Taxi Zones.**

1. On the west side of Broadway, beginning 20 feet from the south corner of Second Avenue and extending 80 feet south.
2. **In the gravel parking lot at Gold Rush Cemetery, 10 feet east of the reader board on the north side of the walkway.**

3. **Broadway, west and east sides, beginning 20 feet from the north corners of Fifth Avenue and extending 80 feet north (shared with Skagway Municipal Authority Regional Transit zone).**

E. **20-Minute Parking Zones.**

1. Broadway between First Avenue and Second Avenue:
  - a. East and west sides, beginning 20 feet from the north corner of First Avenue and extending 80 feet north.
  - b. East side, beginning 20 feet from the south corner of Second Avenue and extending 80 feet south.
2. Broadway between Second Avenue and Third Avenue:
  - a. West side, beginning 20 feet from the north corner of Second Avenue and extending 55 feet north.
  - b. East side, beginning 20 feet from the north corner of Second Avenue and extending 80 feet north.
3. **Broadway between Third Avenue and Fourth Avenue:**
  - a. **East and west sides, beginning 20 feet from the north corner of Third Avenue and extending 80 feet north.**
  - b. **East and west sides, beginning 20 feet from the south corner of Fourth Avenue and extending 80 feet south.**
- ~~34.~~ Broadway between Fourth Avenue and Fifth Avenue:
  - a. East and west sides, beginning 20 feet from the north corner of Fourth Avenue and extending 80 feet north.
  - b. East and west sides, beginning 20 feet from the south corner of Fifth Avenue and extending 80 feet south.
45. Broadway between Fifth Avenue and Sixth Avenue:
  - a. West side, beginning 20 feet from the south corner of Sixth Avenue and extending 80 feet south.
- ~~56.~~ Broadway between Sixth Avenue and Seventh Avenue:
  - a. East and west sides, beginning 20 feet from the north corner of Sixth Avenue and extending 80 feet north.
  - b. East and west sides, beginning 20 feet from the south corner of Seventh Avenue and extending 80 feet south.
- ~~67.~~ Broadway between Seventh Avenue and Eighth Avenue:
  - a. East side, beginning 20 feet from the north corner of Seventh Avenue and extending 80 feet north.
8. **Second Avenue:**
  - a. **North side, beginning 30 feet from the east corner of Broadway and extending 20 feet east.**

F. **Two-Hour Parking Zones.**

1. Second Avenue:
  - a. North side, beginning 30 feet from the east corner of State Street and extending 120 feet east.
  - b. South side, beginning 30 feet from the west corner of Broadway and extending 70 feet west.

- c. South side, beginning 20 feet from the east corner of State Street and extending 80 feet east.
  - ~~e. North side, beginning 30 feet from the east corner of Broadway and extending 20 feet east.~~
2. Third Avenue:
- a. South side, beginning 30 feet from the west corner of Broadway and extending 250 feet west.
  - b. South side, beginning 20 feet from the east corner of Broadway and extending 80 feet east.
  - c. North side, beginning 100 feet from the west corner of Broadway and extending 170 feet west.
  - d. North side, beginning 30 feet from the east corner of Broadway and extending 70 feet east.
3. Fourth Avenue:
- a. South side, beginning 30 feet from the west corner of Broadway and extending 250 feet west.
  - b. South side, beginning 20 feet from the east corner of Broadway and extending 250 feet east.
  - c. North side, beginning 20 feet from the west corner of Broadway and extending 250 feet west.
  - d. North side, beginning 30 feet from the east corner of Broadway and extending 250 feet east.
4. Fifth Avenue:
- a. South side, beginning 100 feet from the west corner of Broadway and extending 180 feet west.
  - b. South side, beginning 20 feet from the east corner of Broadway and extending 200 feet east.
  - c. North side, beginning 20 feet from the west corner of Broadway and extending 250 feet west.
  - d. North side, beginning 30 feet from the east corner of Broadway and extending 170 feet east.
5. Sixth Avenue:
- a. South side, beginning 30 feet from the west corner of Broadway and extending 250 feet west.
  - b. South side, beginning 20 feet from the east corner of Broadway and extending 250 feet east.
  - c. North side, beginning 20 feet from the west corner of Broadway and extending 250 feet west.
  - d. North side, beginning 30 feet from the east corner of Broadway and extending 250 feet east.
6. Seventh Avenue:
- a. South side, beginning 130 feet from the west corner of Broadway and extending 150 feet west.
  - b. South side, beginning 150 feet from the east corner of Broadway and extending 120 feet east.
  - c. North side, beginning 30 feet from the east corner of Broadway and extending 250 feet east.

- d. North side, beginning 20 feet from the west corner of Broadway and extending 250 feet west.
7. The east and west sides of State Street between First Avenue and Seventh Avenue unless otherwise designated, with the exception of no-parking zones required within twenty (20) feet of each intersection.

~~G.~~ **One Hour Parking Zones:**

- ~~1. Broadway between Third Avenue and Fourth Avenue:
  - a. East and west sides, beginning 20 feet from the north corner of Third Avenue and extending 80 feet north.
  - b. East and west sides, beginning 20 feet from the south corner of Fourth Avenue and extending 80 feet south.~~

**H.G. Public Parking Areas.**

1. The property described as a portion of the "Mill Lot," or the parking lot on the east side of Spring Street between Second and Third Avenues.
2. An area south of First Avenue that includes Lots 2 – 6 and Lots 9 – 10, Block 44, **except that Lots 2 – 6, Block 44 are owned by Pacific and Arctic Navigation Company and may only be used as public parking under a valid lease.**
- ~~3. An area north of First Avenue that includes Lots 7 – 9, Block 37, except that the north 40 feet of the lots shall be a no parking zone as specified above.~~

**H. Restricted Parking Zones.**

1. ~~Handicapped~~ **Accessible** Loading Only:
  - a. Southwest end of the turnaround where Congress Way terminates at the Railroad Dock.
2. ~~Handicapped~~ **Accessible** Parking Only:
  - a. One parking space on the southeast side of the City Hall parking lot.
  - b. North side of Third Avenue, beginning 20 feet from the west corner of Broadway and extending 80 feet west.
  - c. South Small Boat Harbor parking lot, first two parking spaces on the south end.
3. No Vehicles in Excess of 19 Feet in Length:
  - a. West and east sides of Broadway from First Avenue to Seventh Avenue.
  - b. North side of Seventh Avenue beginning 20 feet from the east corner of Broadway and extending 130 feet east.
4. Small Boat Harbor Parking Only:
  - a. South end of the parking lot, west of the loading zone by the south ramp to the Small Boat Harbor for use only by harbor users; no commercial passenger vehicles allowed. Parking in this area is limited to 24 hours.


**H.I. Parking Permits.**

1. The Skagway Police Department may provide free parking permits, in compliance with a written policy approved by the borough manager and police chief, to the following parties:
  - a. Year-round residents of Broadway, and First, Second, Third, Fourth, Fifth, or Sixth Avenues;

- i) Determination of year-round status shall be made by the police chief per the approved policy.
  - b. Motels or hotels that can demonstrate parking needs within proximity of their establishment as follows:
    - i) Permits under this section are only valid within the immediate proximity of the motel or hotel;
    - ii) Permits issued shall be restricted to one per motel or hotel room.
  - c. Year-round residents who are 65+ years old.
- 2. Parking permits shall enable permittees to park within restricted zones for longer than the time specified for each zone, per the approved policy.

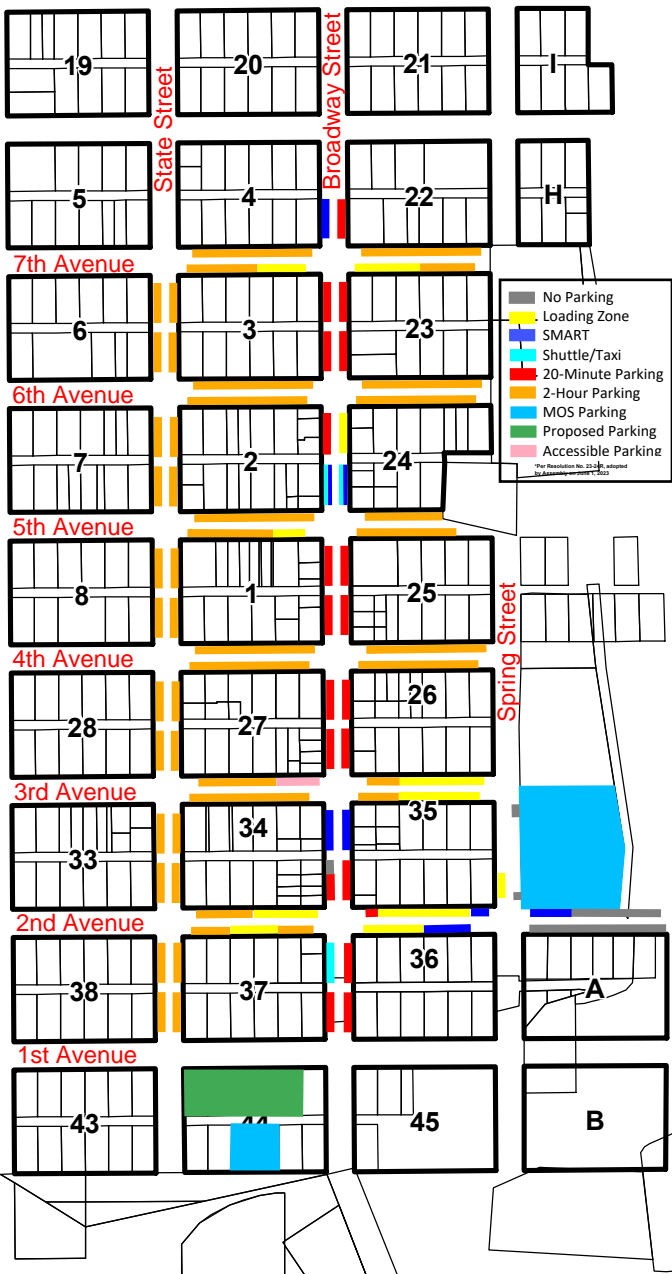
